# INTRODUCTION

The conference that paved the way for the EUA Funding Forum series took place eight years ago in Bologna. At the time, many higher education institutions were struggling with the first effects of budget cuts in the wake of the financial crisis. Policy discourse started to evolve, leading to universities being tasked with more responsibility, while often receiving fewer financial resources. In such a context of multiple pressures, universities found it difficult to develop sound partnerships, enhance the efficiency of their internal operations, and consolidate their institutional profile in a strategic way.

As the university funding and governance community continued to meet at EUA's biennial Forum over the following years, it became clear that institutional leaders and managers, as well as public and private funders had developed a strong appetite for a regular, well-informed dialogue with peers from across Europe. The EUA Funding Forum became a place for exchange on policy experimentation, innovative practices, and the ongoing reform of financial frameworks – all crucial elements that help to understand and contribute to the sector's strategic development.

European universities have worked relentlessly to adapt to their changing environments, both in the ways they deliver on their missions, as well as in their internal processes. Following the discussions held in Porto in 2016, this year's edition of the Funding Forum continues to explore how universities deal with efficiency and effectiveness and monitors progress in the area. Policy makers' interest in the topic has continued to grow, fuelled by changing funding modalities and university governance models, as well as the growing competition among universities and the evolving student body. In Barcelona, we take the discussion forward, with new opportunities for exchange and interaction among participants.

EUA's work in the USTREAM project provides relevant background input to this debate. In the context of USTREAM, which is supported by the European Commission through the Erasmus+ programme, EUA has been working with member associations (Universities UK, Irish Universities Association) and the Central European University on the concepts of efficiency, effectiveness and value for money in higher education and has developed an approach based on two principles:

The concepts of economy (reducing the costs of inputs), efficiency (getting more output for the same or less input) and effectiveness (getting better at what universities set out to do) – sometimes captured through the concept of value for money - are equally important and cannot be considered separately in the higher education context.

The topics of efficiency, effectiveness and value for money are cross-cutting and need to be addressed at all levels of higher education, including the system level (national and regional), the sector level (networks and collaborations) and the institutional level (faculty, departmental and individual) and in all university settings (strategic governance, operational management and academic matters).

With this in mind, EUA's intention for the 4th Funding Forum is to promote structured, evidence-based debates and interaction among university leaders, managers and funders, as well as higher education researchers and sector representatives on the topics of efficiency, effectiveness and value for money. The guiding thread of the event will be: how to achieve adequate frameworks for leading and managing successful change in the university sector, and how to support leaders in engineering sustainable change in challenging contexts. The event will feature "Learning Cafés" and "Reform Roundtables" in an effort to promote high-quality exchanges. "Master Classes" and "Expert Rooms" will showcase hands-on experiences and offer concrete ideas that interested colleagues can take home. EUA Funding Forum speakers and panellists will strive to provide useful insight and inspire their peers to take action. EUA would like to thank all participants for their active contribution to this platform, and for being part of this growing community.

Josep Garrell i Guiu Rector, Ramon Llull University, Spain

Josep M. Garrell holds a Computer Engineering degree and a PhD in Electronic Engineering (1995). As a faculty member and researcher at Ramon Llull University (URL), he specialised in the area of Artificial Intelligence and Machine Learning. At Ramon Llull University he has held several positions concerning university policy and management: Vice-Rector for Research and Innovation (2002-2010), Secretary General (2006-2012) and Vice-Rector for University Policy (2010-2012). During his mandate as Secretary General, he led the project Aristos Campus Mundus' 2015 (ACM) awarded with the Campus of International Excellence by the Spanish Ministry of Education. ACM is a strategic partnership

between three social initiative universities, Deusto University (Bilbao), Comillas Pontifical University (Madrid) and Ramon Llull University. In 2012, Josep M. Garrell was appointed Rector of Ramon Llull University and his mandate was renewed for a second four-year period in 2016. Since 2016 he is a member of the Spanish Rectors' Conference (CRUE) board.



José Manuel Pingarrón Carrazón Secretary General of Universities Spanish Ministry of Science, Innovation and Universities

José M. Pingarrón obtained his PhD (1981) from Complutense University of Madrid. He is Full Professor of Analytical Chemistry at the Faculty of Chemical Sciences at the Complutense University of Madrid since 1994 and former Vicerector of Knowledge Transfer and Entrepreneurship. His research work focuses on analytical electrochemistry, nanostructured electrochemical interfaces, nanomaterials and electrochemical sensors and biosensors.

He was the President of the Spanish Society of Analytical Chemistry between 1998 and 2001 and Executive Secretary of the R&D&I division of the Spanish Rectors Conference (CRUE) from 2016 to 2018. Moreover, he is a founding

member of the Forum of Innovative Companies (FEI) and co-founder of the "spin-off" company Inbea Biosensores S.L. Since June 2018, José Manuel Pingarrón Carrazón is Secretary General of Universities, and as such oversees the development of the university policy in coordination with the Council of Universities and the coordination of the relations with the autonomous communities in university matters through the General Conference of University Policy.



Rolf Tarrach
President, European University Association

Rolf Tarrach was Rector of the University of Luxembourg from 2005 to 2015. He studied physics at the University of Valencia and obtained his PhD from the University of Barcelona. Rolf Tarrach subsequently served as a postdoctoral researcher at CERN, Geneva, and was Professor of Theoretical Physics at the Universities of Valencia and Barcelona. He has published more than 100 papers and two books and has been honoured with a honoris causa degree from the University of Saint Petersburg, Russia. He is the recipient of eight official prizes

and was Dean of the School of Physics and Vice-Rector of the University of Barcelona. Rolf Tarrach is the former president of CSIC Madrid (the Spanish Scientific Research Council) and a former member of the European Union Research Advisory Board, of the European Heads of Research Council group, which he also chaired and of the five-year assessment panel of experts of the European Commission. He has been a coorganiser of the first three EuroScience Open Forums (ESOF). In 2008, he became President of the Academic Cooperation Association (ACA) and was Vice-Chair of the jury of the French Initiative d'excellence from 2011 to 2012, and from 2015 to 2017. Rolf Tarrach continues to be Professor of Physics at the University of Luxembourg. He has been Council Member of the European University Association (EUA) for ten years.

Thomas Estermann
Director, Governance, Funding and Public Policy Development, European
University Association

Thomas Estermann is Director for Governance, Funding and Public Policy Development with responsibilities for EUA's work aimed at strengthening universities' autonomy, governance, management and their financial sustainability. #### Plenary session: Efficient university management & efficient frameworks



Edeltraud Hanappi-Egger Rector, Vienna University of Economics and Business, Austria

Edeltraud Hanappi-Egger is a computer scientist by education, as well as an experienced researcher and head of interdisciplinary teams. Since 2002 she is Full Professor for gender and diversity in organisations at Vienna University of Economics and Business. She worked as a guest researcher at various national and international research institutions and her work was awarded several times. She is an expert in organisation studies and gender topics and as such has published more than 350 articles, books and book chapters on gender and diversity, organisation studies and diversity management. In 2014 she received the Jean Monnet Chair for "Gendered Inequalities and Classism in Europe" from the European Commission. Since October 2015 she is Rector of the Vienna University of Economics and Business.



Philip Nolan President, Maynooth University, Ireland

Philip Nolan earned his degrees in Physiology and Medicine in 1988 and 1991 and a PhD for his research on the control of breathing and the cardiovascular system during sleep from University College Dublin (UCD). He joined the staff of UCD in 1996. In 2004 he became Registrar and Deputy President at UCD. In August 2011, he was appointed President of Maynooth University. Early in his tenure he established a new strategy for the University in its research, teaching and engagement activities. He initiated a university-wide review to re-imagine the University's undergraduate curriculum and this new curriculum was launched in 2015. Many of the changes—which range from broader entry

routes and language study to increased course flexibility and discipline combinations—are considered sector-leading among Irish higher education institutions.

He has played a leading role in reforming the transition from second to third level, in widening participation in higher education, and in promoting equality and diversity. The Maynooth University Strategic Plan 2018-2022 emphasises further enhancement of research capacity, significant development of the postgraduate portfolio, comprehensive internationalisation, and equality, diversity and inclusion.

#### Plenary session – An efficient funding landscape: Aligning funders' practices?



Yngve Foss
Special Adviser, Research Council of Norway

Yngve Joseph Foss is Special Adviser and Team Leader of the Instruments for Internationalisation team in the Research Council of Norway. He was previously Head of the Research Council of Norway Brussels Office, a position he held from 2013 until 2017. Before joining the Research Council of Norway, he served as Senior Legal Adviser and Head of Section at the University of Oslo, where he was responsible for setting up the first EU Grants Office at the university. He holds a Master of Laws (LL.M) degree, and a Bachelor of Arts degree in Communication Arts.



Jean-David Malo
Director Open Innovation & Open Science, European Commission

Jean-David Malo studied at the Institut National Supérieur des Sciences Economiques et Commerciales in Paris and the University of California in Berkeley. He started his career as Head of Internal Control Management in the Comité Professionnel de la Distribution de Carburants in France before joining ARMINES, a body managing contractual research and innovation for French engineering schools, where he created, developed and managed the European Affairs Directorate. He joined the European Commission in January 2001. In the Directorate General for Research, he participated actively in a number of developments on the design of funding instruments, rules for participation and

funding schemes, both for FP6 and FP7. From 2003 to 2006, he was the assistant of Director Robert-Jan Smits. From 2006 to 2010 he headed the unit in charge of the regional aspects of FP7, and from 2011 to 2013 he managed a newly created unit in DG Research and Innovation. The main objective of this new unit was to contribute to increase private finance and close market gaps in investing in research and innovation by expanding the scope and scale of existing EU innovative financial instruments and by developing new ones in the fields of debt and equity financing, notably in the context of Horizon 2020. The work of the unit also covered the EU state aid framework, tax incentive schemes and philanthropic funding; and from 2014 the SMEs dimension of Horizon 2020, including in particular EUROSTARS II and the design and coordination of the SME Instrument and the Fast Track to Innovation pilot. In February 2017 Jean-David Malo was appointed as Director of the Directorate in charge of Open Innovation and Open Science.



Francesca Maltauro
Head of the Erasmus+ team of the Higher Education Unit, Directorate General for Education and Culture, European Commission

Francesca Maltauro is Head of the Erasmus+ team of the Higher Education Unit at the Directorate General for Education and Culture of the European Commission. She is responsible for the implementation of the Erasmus+ programme in the higher education sector, and she is currently working on the preparations of the next MFF cycle programme negotiation and implementation, with particular focus on the flagship initiative: "European Universities". Before joining the European Commission in 2016, she worked for two years in the Institutional Development Unit of the European University

Association. Before that, she worked for 7 years at the International Relations Office of the University of Bologna, where she was in charge of Erasmus Mundus projects and student mobility. Stephen Hwang Vice-Chancellor, Halmstad University, Sweden

Stephen Hwang is Vice-Chancellor of Halmstad University since March 2017. Prior to this he was the first Vice-Chancellor of Linnaeus University, which was founded through a merger of two older institutions in 2010. He has a long career as a researcher in Theoretical High Energy Physics. He received his PhD from Chalmers University of Technology and has been a researcher at Chalmers University of Technology, University of Texas and at the international research centre CERN. Before becoming Vice-Chancellor of Linnaeus University, he was Dean of the Faculty of Science and Technology at Karlstad University.

In the role of Vice-Chancellor, he is aiming at further developing Halmstad University as a first-class teaching and research institution, combining strong

traditional academic values in an international knowledge arena. Halmstad University is committed to creating values in close participation with partners from society, and with a strong innovation profile. Stephen Hwang is also highly active on the national arena, being part of the board of The Association of Swedish Higher Education Institutions (SUHF) as well as the board of the Swedish Agency for Government Employers. He has also been chairman of the Expert group on Quality issues within SUHF for three years. This group has among other things studied different national funding models for higher education and research and he is the main author of an international overview of different funding models and their effect on quality.



Esa Hämäläinen Director of Administration, University of Helsinki, Finland

Esa Hämäläinen is currently the Director of Administration of the University of Helsinki, with an overall responsibility of the university administration. With the support of DAAD and Alexander von Humboldt Foundation scholarships he worked in the universities of Regensburg, Cologne and Nueremberg-Erlangen (Germany). His research

interests include genetics and physiology of recombinant micro-organisms, and influence of the unspecific immune response modulators upon the differentiation of adult stem cells.

Indriķis Muižnieks is Full Member of the Latvian Academy of Sciences and is Chairman of the Research Expertise Committee of the Latvian Council of Science. He participated in the EU CREST Working Groups, and Programme Committees of the European Science Events, and served as National Expert in the European Food Safety Organisation. Liviu Matei is Provost of the Central European University Budapest (CEU) and professor of higher education policy. He also serves as Director of the Yehuda Elkana Centre for Higher Education at CEU, which specialises in applied research in higher education policy. He taught at universities in the United States, Romania and Hungary, and consulted for UNESCO, the Council of Europe, the World Bank, the Commission of the European Union, other international intergovernmental and non-governmental organisations with activities in higher education, as well as governments in Europe and Asia. He is a member of the editorial board of the Journal of the European Higher Education Area.



Maria Àngels Chacón i Feixas Minister of Business and Knowledge, Catalonia

Àngels Chacón holds a Bachelor's degree in Law from the University of Barcelona and is specialised in foreign trade. In 2017, she received her postgraduate degree in Talent Management in Organisations, also from the University of Barcelona. In June of that same year, she became the Government of Catalonia's Director General for Industry, but she had already been serving as deputy mayor and councillor for Economic Dynamisation, Knowledge, Internationalisation and Home Affairs at Igualada Town Council since 2015. From March 2005 to June 2011 Manuel Heitor served as Secretary of State of Science, Technology and Higher Education. In 2011 and 2012 he was Invited Professor at Harvard University. He is Research Fellow at the Institute of Innovation, Creativity and Capital of Texas University. He initiated and

coordinated several international conferences related to Technology Policy and Innovation and is a co-editor of the Purdue University Press book collection on Science and Technology Policy. He was one of the promotors of the European network step4EU, science, technology, education and policy for Europe, and the International Observatory of Global Politics for the Exploitation of the Atlantic Ocean.

## Efficiency, effectiveness and value for money

#### Universities for Strategic, Efficient and Autonomous Management

USTREAM seeks to examine the measures that are in place in universities across Europe to enhance efficiency at operational level, and also analyse policies at system level that support universities in their efforts to operate more efficiently, with a view to identify good practice examples and develop recommendations for further development. The project addresses the question of operational efficiency in universities in a European comparative way. It offers a novel approach to the topic by tailoring it to the specificities of the higher education sector and breaking it down into three thematic dimensions:

- efficiency in professional, operational and support services
- · efficiency in academic matters, and
- efficiency through strategic governance.

USTREAM is co-funded by the European Commission under the Erasmus+ programme (2014). The USTREAM project runs from January 2016 until mid-2019.

#### **University Efficiency Hub**

This online portal, accessible at www.efficiency.eua.eu, has been developed under the USTREAM project.

The University Efficiency Hub is based on the selected findings and data collected by the USTREAM project, drawing on the experience of more than 100 higher education institutions and more than a dozen of higher education systems across Europe.

The following features are offered through the University Efficiency Hub:

- The portal provides useful background data on general framework conditions for efficiency, effectiveness and value for money at the system level, supported by comprehensive datasets on shortand long-term public funding and autonomy trends across Europe.
- The portal offers access to a dynamic database of good practices in efficiency and effectiveness that can be consulted at various levels and in different university settings.
- The portal offers higher education institutions a possibility to self evaluate the internal structures and measures for efficiency and effectiveness.

#### Report: Efficiency, Effectiveness and Value for Money: Insights from the UK and other countries

This report provides a summary of the input, discussions and findings from the first USTREAM peer learning seminar on policy frameworks for efficiency and effectiveness in the higher education context, which took place on 1st and 2nd June 2017 in London.

The seminar was jointly organised by Universities UK and the European University Association to foster the exchange of good practices and strategies pursued by higher education institutions across Europe to address efficiency-driven policy priorities and tackle the related challenges, opportunities and pitfalls.

#### Report: Efficiency, Effectiveness and Value for Money: Insights from Ireland and other countries

This second report provides a summary of the input, discussions and findings from the second USTREAM peer learning seminar: National and institutional approaches to delivering efficiency, which took place on 4th and 5th December 2017 in Dublin.

This report provides an overview of a broad range of measures implemented by the Irish government and the higher education institutions against the challenging background of the significantly reduced public budget for higher education at a time of substantial growth in student numbers. The EUA analysis of the current funding trends shows that many higher education systems in Europe face similar issues, which makes the Irish experience highly relevant and inspiring for such systems.



## Efficient funding of universities: impactful simplification

# Accepting University Accounting Practices under Horizon Europe - A compendium of national and institutional cases

Simpler management of EU funding has long been associated with the provision of a single set of rules to all beneficiaries of EU programmes. However, as revealed through the work of EUA, while this option supports clarity and certainty of action, it fails to acknowledge participants' diverse profiles. These could be better met through the provision of several options to accommodate different needs, including a framework for improving acceptance of beneficiaries accounting and management practices.

Ahead of the adoption of the Commission's proposal establishing Horizon Europe, university practitioners from 12 European countries provide solid data based on their direct experience managing national and EU funded research projects. The report features practical information on accounting practices applied to the management of nationally funded research projects. These are compared to current Horizon 2020 rules to explore possibilities for a better alignment of practices between the EU and the national level under Horizon Europe.

The report aims to contribute to the transparency of the discussions promoting a broader acceptance of institutional practices as a major step towards simplifying EU funding. It builds on EUA's earlier work on <u>financially sustainable universities</u> by providing updated information about the current state of development of costing methodologies in European universities. The analysis shows that universities across Europe have a professional financial management and that many European research funders accept their institutional practices.

#### Report: Impactful Simplification of the EU Framework Programme for Research and Innovation

Simpler rules for participation have the potential to increase the added value and improve the efficiency and impact of EU funding. For Framework Programme beneficiaries, this primarily involves reducing the incompatibilities between EU funding requirements and institutional financial management systems.

Universities are established institutions with professional financial management procedures that are regulated and audited at national level. Therefore, EUA recommends embracing and making operational a trust-based approach that can support a greater alignment between European, national and regional programmes.

This is best achieved by improving acceptance of institutional accounting practices and EUA proposes to make it operational by providing beneficiaries with the following options:

- Elaborating an adequate, functional procedure for certifying national and institutional accounting methodologies at the beginning of the Horizon Europe programme;
- Developing improved rules based on current Horizon 2020 procedures.

Moreover, beneficiaries should be able to opt for new and simplified funding methods and be allowed to choose to continue using successful management systems already put in place in Horizon 2020. As guiding principles, such simplified funding methods should effectively reduce the administrative burden, ensure fair accessibility and competition, and ensure transparent financial management.

#### Position paper: Taking simplification of EU Funding to the next level - The university perspective

As the European Union prepares the next generation of EU funding programmes for the post-2020 period, budget discussions are increasingly geared towards performance, European added value, trust and efficiency. Simplification is a cornerstone in the debate as it is seen as a way to achieve these goals, lower entry barriers to programmes (thus improving participation throughout Europe), and overall to maximise the impact of EU funds. Universities are directly interested in the discussions on simplifying the access to and management of projects in a wide range of EU funding programmes.

Universities cautiously assessed the potential for real simplification of the proposed measures for beneficiaries and consider that there is a need to re-focus on more effective simplification solutions. Simplification should be about achieving a coherent set of rules that is mindful of the diversity of actions and beneficiaries accommodated in a programme, and that ensures both high quality processes and an effective use of resources.

## Sustainable funding

#### Position paper: Ambitious funding for excellent research in Europe post-2020

This position paper reiterates the strategic importance of fostering a united and prosperous knowledge-based society in Europe, which needs to remain a high priority despite the uncertain political and economic context. Despite its high impact on society and economy, Horizon 2020 is significantly underfunded. Therefore, EUA advocates for a quantitative and qualitative increase in EU research funding for the next EU Framework Programme for Research and Innovation (FP9) and suggests to open a discussion on a possible ring-fencing or shift of funding from European structural and investment funds (ESIF) or other sources for a more ambitious and well-functioning research programme.

The position paper embodies the sector's views on the topic shaped by the Horizon 2020 mid-term review, the EUA Vision for FP9 and consultations of EUA's Research Policy Working Group and its Expert Group on Regional Strategies for Smart Specialisation.

#### Public Funding Observatory www.bit.ly/EUAPFO

EUA keeps a close eye on public funding for Europe's universities. Its Public Funding Observatory captures the very latest trends impacting Europe's universities and offers the most up-to-date information on dozens of different higher education systems across the continent. The data is laid out in a series of reports and in an interactive online tool, which is updated annually. The Observatory provides a unique international benchmarking tool and is used by policy makers and sector representatives alike to support the national dialogue on university funding.

#### **EUA campaign: EU Funding for Universities**

Improving funding conditions for universities in the next generation of European funding programmes

The significant underfunding of Horizon 2020 has led to a critically low success rate and heavily weighs on the overall efficiency of the funding landscape. Participation remains expensive for universities, especially for less funded institutions in Europe. In this context, EUA calls on member states to provide sufficient and sustainable national public funding for education, research and innovation, which is paramount to support the participation of universities in Horizon Europe and enable them to co-fund the projects.

National public authorities, and in particular ministries of finance must support higher investment in research, education and innovation at the EU level. In the context of the negotiations on the next multiannual financial framework, they must be convinced of the added value of higher investment in this sector at both the national and EU level.

EUA has developed material summarising the arguments in favour of EU-level investment in research and innovation and in higher education. The "Reasons to step up EU-level investment in Research & Innovation" and "Reasons to step up EU-level investment in Higher Education exchange and cooperation" are available as two-pagers and as individual postcards that can be used on social media. The material is available to national rectors' conferences in a format can be adapted to their national context.


